GENERAL:

Modifications described herein as Addendum items supersede specific parts of the Contract Documents for the above-named project. All bids and the construction contract shall be based on the inclusion of these modifications.

GENERAL INFORMATION to BIDDERS

ITEM 1: BMS system is manufactured by Siemens. Contact Frank Pepe at (860) 262-4886 (M), Siemens Industries, 104 Sebethe Drive, Cromwell CT 06416.

ITEM 2: As discussed in Pre-Bid Meeting #1, held on Aug. 14, 2024, acceptable generator manufacturers are, in order of preference: Caterpillar (basis of design), Cummins, and Kohler. Generac will not be accepted.

ITEM 3: As discussed in Pre-Bid Meeting #1, held on Aug. 14, 2024, the following clarifications were discussed:

- a. Griffin Hospital will provide all conductors and wiring for the transfer switches, including normal, emergency and load interconnections. Contractor shall terminate emergency feeds inside the EGESBB switchboard, with Griffin Hospital electrician in attendance.
- b. All start circuits for the new transfer switches shall be provided by Griffin Hospital. Terminations inside switchboard will be by the contractor, with Griffin Hospital electrician in attendance.
- c. The eyewash station in the generator room (not shown on the drawings) will be removed/relocated by Griffin Hospital.
- d. The existing 1250KW generator that serves the Hospital loads serving the Hospital's EPSS shall remain as installed. The new 1250KW generator is intended to only provide standby power to the three chillers and associated MCCs that are currently on normal only power. The new 2000A transfer switch (MTS-GEN) shall be used to feed the either the three chillers and associated MCCs or the existing EPSS. Using the transfer switch will allow the hospital to keep emergency power available to the hospital when the existing generator is either down for maintenance or otherwise being serviced or if the existing generator fails while in operation.
